OFFICE ORDER

Constitution of Anti-Ragging Committee —Year 2026-27

Authority: UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 (Regulation 6.3a) and Hon'ble Supreme Court of India judgment dated 08.05.2009.

Note on Student

Representative Transitions:

1. 3rd Year Student (Sl. No. 13 — Maria VL Ruatfeli):

Upon completion of the final year programme in September 2026, Ms. Maria VL Ruatfeli shall cease to be a member of this committee with effect from September 2026. A suitable replacement from the then-current 3rd year batch shall be nominated by the principal /chairperson and a formal Amendment Order shall be issued.

2. 1st Year Fresher Student Representative & 2nd year student representative (Sl. No. 14,15):

As per UGC Regulation 6.3(a), the committee must include a representative from the freshers' category at all times. Upon joining of the new batch in August 2026, the 1st year fresher representative shall be updated accordingly. Ms. Carefully Mukhim, Ms. Pushpa Kumari Roy (current 1st & 2nd year) shall move to the Senior Student category. The incoming fresher representative shall be nominated by the Principal and an Amendment Order shall be issued in August 2026.

3. Annual Reconstitution: Student representatives shall be reviewed and updated at the beginning of every academic year. All other members shall continue unless replaced by a specific order.

Duties and Responsibilities of the Anti-Ragging Committee:


- Ensure compliance with UGC Anti-Ragging Regulations 2009 and all applicable laws.
- Receive, investigate and resolve ragging complaints within 7 working days.
- Monitor and oversee the performance of the Anti-Ragging Squad.
- File FIR with police within 24 hours of receiving a ragging complaint.
- Conduct awareness programmes and orientation for freshers each academic year.
- Conduct discreet random surveys among freshers every fortnight during the first three months.
- Submit weekly compliance reports to the University/Affiliating Body.
- Ensure display of Anti-Ragging Helpline (1800-180-5522) at all prominent locations.
- Ensure all students and parents submit online Anti-Ragging affidavits annually.
- Take punitive action against those found guilty as per UGC Regulations.

Tenure: Year April 2026- April 27 or until further orders, subject to annual review of student representatives.

Meetings: The committee shall meet at least once every quarter. Minutes shall be recorded and maintained.

Complaints: Complaints may be lodged with the Member Secretary /Nodal officer or Chairperson and shall be addressed within 7 working days.

All members are hereby directed to take charge of their respective responsibilities with immediate effect.
